Pickup & Drop-Off Hours

We are pleased to offer pick up and drop off options 7 days a week! We are closed on Christmas Day.

Monday – Friday: 8:00 - 10:30am or 4:30 - 6:30pm

Saturday: 8:00 - 10:30am only | **Sunday:** 4:30 - 6:30pm only

We are not open for pickup or drop-offs outside of these posted hours.

If you require a special appointment, you must schedule a drop-off/pick-up time AT THE TIME you make your reservation.

ANY pickup or drop off outside of the posted hours, including appointments, will incur a \$50 fee.

Cancellations or changes within 24 hours of your scheduled drop off time are subject to a \$30 fee, particularly during peak times (US Holidays, Spring/Fall Break, etc.)

If you need to alter the duration of your dog's stay, please call us at (765) 460-2223 and we will adjust your reservation. However, we will not open outside of our scheduled hours for you to pick up unless there are extenuating or emergency circumstances.

Boarding Rates & Fees

Effective January 1, 2024

1 dog - \$30.00/day | 2 dogs/shared kennel - \$54.00/day | 3 dogs/shared kennel - \$78.00/day

Charges begin the day your dog arrives. There is no charge for the day if your dog is picked up during our morning hours (8:00 - 10:30 AM). If your dog stays past 10:30/until the afternoon hours, there will be a day's charge.

If your dog is fed our Kennel Diet, there will be an additional \$3-\$5 charge PER DAY on your final bill. If we need to purchase any food to feed your dog, the cost of the food will be added to your final bill.

*There are no extra charges for administering medication, walks, playtime, etc.
We consider this to be a part of our regular care routine and include these services in our daily rates.*

As a condition of using our services for your dog(s), the following must be initialed & signed:

Initials ____ I have reviewed the pickup and drop off hours and agree to pay the rates that are in effect at the time my dog stays at Riverside Dog Resort, LLC.

Initials ____ I authorize Riverside Dog Resort, LLC to engage the services of a veterinarian, if necessary, at my expense. If I cannot be reached, or there is not sufficient time to reach me, I give Riverside Dog Resort, LLC authority to make whatever decisions are required for my dog's veterinary treatment, including, but not limited to, requesting any and all veterinary records from the veterinarian identified on Page 1 & Page 2 of this agreement. I agree to pay all veterinary charges incurred by my dog while in the care of Riverside Dog Resort, LLC whether incurred from the veterinarian identified on Page 1 or any other veterinarian. I will not hold Riverside Dog Resort, LLC liable for failure to seek veterinary attention, or for other decisions made by Riverside Dog Resort, LLC pursuant to the provisions of this agreement.

Initials ____ I understand that Riverside Dog Resort, LLC agrees to house the dog in sanitary and appropriate conditions and to provide the dog with proper exercise, nutrition, and care. I hereby waive, release, and hold harmless Riverside Dog Resort, LLC, its employees, owners, agents, and representatives from any and all liability of any nature, or for any injury or damage, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Riverside Dog Resort, LLC, while on the property of Riverside Dog Resort, or the surrounding area.

Initials ____ Owners are welcome to bring their own blankets, toys, chew bones if desired. However, Riverside Dog Resort, LLC cannot guarantee that they will be returned in the same condition, or at all (e.g. if your dog shreds or chews the beds/toys, etc.). We provide raised cot bedding at no charge. If you want to send blankets or bedding, please ensure the items are washable. Please label any items you bring for your dog. Riverside Dog Resort, LLC is not liable or responsible for any items provided by the owner.

Initials ____ Owners are responsible for any damage their dog causes to the kennel's personal property, equipment, or facilities. This includes, but not limited to, damage to kennel fencing, kennel cot beds, etc.

Initials ____ Owners agree to pay for the cost of any food purchased by Riverside Dog Resort, LLC and as permitted under this agreement.

Initials ____ Owner understands that grooming services offered by Riverside Dog Resort, LLC are subject to availability/scheduling and the temperament of owner's dog(s). This provision applies even if grooming services were requested at booking/drop-off. Owners will not be charged for grooming services if none were offered. However, if, during its stay, your dog(s) becomes particularly dirty it will be groomed, and/or bathed, at owner's expense. By initialing here, Owner expressly agrees to pay for any grooming services rendered by Riverside Dog Resort, LLC even if not those services were not requested by Owner.

Initials ____ All dogs must be healthy, and current on Rabies & DHPP vaccinations. You will be required to bring a copy of your dog's updated vaccination records from your vet before you start daycare or board with us to ensure your dog's safety as well as that of our other guests. We require the Bordetella vaccine. A first time Bordetella vaccine MUST be given at least fourteen (14) days prior to any boarding/daycare stay with us. By initialing here, owner states that their dog(s) have received their first time Bordetella vaccine at least fourteen (14) days prior to any boarding/daycare at Riverside Dog Resort, LLC or has received their booster/repeat Bordetella vaccine in accordance with expiration dates on vaccination records prior to any boarding/daycare at Riverside Dog Resort, LLC.

Initials ____ Owner is aware that by leaving their dog at Riverside Dog Resort, LLC., or any other pet facility, they are at a higher risk of contracting canine cough (kennel cough), viruses, or acquiring nicks, cuts, and possibly punctures from interacting with other dogs. Canine cough (kennel cough) is similar to the flu in humans and no vaccination is 100% effective. We maintain a very high level of cleanliness but interaction with other dogs carries with it inherent risks and Riverside Dog Resort, LLC is not liable for injuries or damage resulting from these inherent risks.

Initials ____ Owners understand and agree that this agreement constitutes the entire agreement between Riverside Dog Resort, LLC and the undersigned, except that any waivers, documents, or other agreements entered into between the undersigned and Riverside Dog Resort, LLC shall be incorporated herein.

On behalf of myself and any and all other owners of this dog(s), I have read and agree to the terms of this contract. By signing said contract the undersigned expressly waives, releases, and forever discharges Riverside Dog Resort, LLC from any and all claims for damages or injuries resulting from the boarding of the undersigned's dog(s). The undersigned further expressly agrees to protect, defend, indemnify, and hold harmless, to the fullest extent of the law, Riverside Dog Resort, LLC, its owners, agents, employees, and representatives from and against any liability, claim, damage, loss, demand, lawsuit, cost, and expense arising out of, or as a result of, the boarding or the undersigned dog(s). I further warrant that by signing this Boarding Agreement I have the authority to represent any and all other owners of this dog(s).
